Water Rules!

Local Advocates Learn How to Put Good Laws to Work

Citizens across Illinois value their streams as wonderful places to hike, fish, watch wildlife, and canoe, among other activities. However, unchecked urban growth is threatening to compromise these activities by polluting streams in many parts of the state. On February 26th, Friends of the Fox River were hosts for Chicago-area residents and clean water advocates who gathered in Batavia for a day long workshop on protecting their streams from potential degradation associated with rapid urbanization and sprawl.

Richard Acker of Openlands Project and Cindy Skrukrud of the Sierra Club joined Prairie Rivers Network's Beth Wentzel in presenting several stream protection tools available through the federal Clean Water Act and state and local regulations. The speakers led discussions on opportunities to encourage smarter growth using Facility Planning Areas, or local sewer system boundaries, which often guide future development. They also discussed strategies to limit pollution that is discharged to local streams and to limit stream and wetland habitat destruction through federal Clean Water Act permitting programs.

Particular emphasis was given to opportunities for citizens to effectively participate in programs to control stormwater, which carries dirt and other pollution from construction sites and developed areas to our rivers. This included an exciting new presentation to teach participants to identify problems at construction sites and to report those problems to enforcement agencies.

In a productive conclusion to the day, each participant identified, and committed to taking, specific actions in his/her community using the information and skills acquired to protect local streams. Prairie Rivers looks forward to continuing to work with participants in carrying out those action plans!

Dynegy Settlement Benefits Illinois Air and Water

On March 7, 2005, environmental groups from around the state announced they had settled a Clean Air Act (CAA) lawsuit against Dynegy Midwest Generation (DMG), which will result in cleaner air and water in Illinois. The lawsuit was first filed by the federal government in 1999 and joined by environmental groups and the Illinois Attorney General in 2003.

In the suit, the U.S. alleged that DMG violated provisions of the CAA by modifying its coal-fired power plant in Baldwin, Illinois without installing modern pollution controls as required by the law. Following the Bush Administration's issuance of new regulations exempting similar modifications from the CAA, it appeared the U.S. would not pursue the case, abandoning key legal arguments in a post-trial brief.

The Environmental Law and Policy Center (ELPC) in Chicago then filed a motion to intervene on an emergency basis on behalf of Prairie Rivers Network and three other Illinois environmental groups—the American Bottom Conservancy, Health and Environmental Justice St. Louis, and Illinois Stewardship Alliance. The motion was granted, along with a similar motion filed by the Illinois Attorney General. As interveners, ELPC and the Illinois Attorney General stepped in to make the key legal

arguments that the U.S. was no longer willing to make. This led to negotiations to settle the case.

As a result of the settlement, DMG will install \$500 million worth of air pollution control equipment on the Baldwin plant and four others it operates in the state. It will pay a \$9 million civil penalty and spend \$15 million on environmental mitigation projects. Several of these projects will directly benefit Illinois' rivers, fish, and wildlife. Specifically, natural land and habitat along the Illinois River in the St. Louis area will be protected, and sediment from the Illinois River will be used to create and enhance wetlands and along the river between two of DMG's plants.

In addition, DMG will give the Department of Natural Resources a 1,135 acre tract that it owns along the east side of the Middle Fork River—the state's only nationally designated Scenic River—providing a link between Kickapoo State Park and the Middle Fork State Fish and Wildlife Area. The land will be permanently protected, maintaining an important wildlife habitat corridor and increasing recreational opportunities along the river.

Finally, DMG agreed to install and commence operating by June of 2007, new equipment that will reduce mercury pollution from their Vermilion power plant by up to 90%. Coal-fired power plants are the last unregulated source of mercury emissions in the U.S., and Illinois currently has a statewide fish advisory in effect because of mercury pollution. The Vermilion plant will be one of the first in the nation to utilize the system known as activated carbon injection on a regular basis, with the goal of 90% mercury reduction. It will demonstrate that such reductions are possible now and should be the requirement for all power plants around the country.

On March 12, the **Vermilion River Task Force** had a Watershed Wide Meeting to present the ideas in their

This group shows what a little determination and hard work can do for a community and a river. Thanks to Judy's ideas and leadership this will be a very successful and fun clean-up.

In the Chicago area, **Friends of Salt Creek** have been busy planning several "Meet the Creek" days and clean-ups starting this spring.

Construction Sites, Water Quality, and You

CONSTRUCTION SITE CHECKLIST

- ☐ Are natural features (e.g. trees, wetlands, streams) protected with fencing or other barriers?
- ☐ Is there vegetation surrounding the edge of waterways?
- ☐ Is construction being conducted in phases to minimize erosion?
- ☐ Are storm drain inlets protected?
- ☐ Is bare soil covered with straw, mulch, or fabric?
- ☐ Are slopes graded or terraced to prevent soil erosion?
- ☐ Are site exits covered with gravel to keep soil on site?
- ☐ Are there silt fences (black material) installed around the site?
- ☐ Do the silt fences prevent soil from leaving the site?

If you answered NO to any of the above, the site may be in violation of IEPA permits and should be reported.

As spring approaches, you will probably see many construction projects underway in your neighborhood. If you notice a lot of dirt coming off the site, this can be a serious problem for rivers and wildlife. The EPA estimates construction site runoff rates to be typically 10-20 times greater than those from agricultural fields and 1,000 to 2,000 times greater than those from forested lands (EPA, Jan 2000).

Dirt tracked into roads or washed off the construction site is picked up by stormwater runoff and flows into streams smothering streambeds, destroying habitat, and muddying the water, making it difficult for fish to see their prey. Fortunately, you have the ability to help prevent this.

According to Clean Water Act regulations, soil must be contained on site to the extent possible and construction sites may not harm streams. To comply with the law, each construction site greater than one acre must develop and implement a Storm Water Pollution Prevention Plan. The plan describes the steps the contractor will use to prevent soil from leaving the site. Unfortunately, the Illinois Environmental Protection Agency (IEPA) does not have the resources to review and enforce these plans. Municipalities also do not frequently monitor sites to ensure that plans are followed. It is up to local citizens to ensure that the law is being followed.

If you are concerned about runoff from a construction site, request a copy of the Stormwater Pollution Prevention Plan from the developer. These documents must be made available to the public. You can also conduct your own spot inspections of the site using the attached list. If your review reveals that runoff from the site is not being prevented, report it to your local municipality's public works department and your local IEPA field office.

Several things are happening this legislative session that could have an impact on the waters and streams of Illinois.

SB 2076, sponsored by Sen. Don Harmon, would ban the sale of dishwashing detergent and other cleaners that contain phosphorus. Phosphorus in home wastewater ends up at your local sewage treatment plant. If not removed before the plant releases its treated water, it can cause algae growth and loss of oxygen in the receiving stream. A proposal is pending to require treatment plants to limit their discharge of phosphorus, and reducing it in home wastewater will facilitate this effort.



SB 1695, sponsored by Sen. Terry Link, would create a Wetlands Protection Program for the last remaining wetlands in Illinois. The bill passed out of its Senate committee, however, a bill that would weaken existing county wetlands programs in northeastern Illinois also passed, **SB 761**, sponsored by Sen. James Clayborne.

Of significant concern is Governor Blagojevich's proposal to take money from the hundreds of **dedicated state funds** to pay for other programs. Among the funds targeted are Open Space Land Acquisition and Development, Natural Areas Acquisition Fund, Conservation 2000, Illinois Clean Water Fund, Used Tire Management Fund and many more environmental and conservation related funds. Go phosphorus-free for Illinois rivers!

While phosphorus was banned from laundry detergent years ago, it is still used in most dishwashing detergents. If you want to go phosphorus-free in your dishwasher, Consumer Reports recently rated the effectiveness of several detergents, and three powders that were phosphorus-free were rated at very good or excellent: Trader Joe's brand, Seventh Generation, and Ecover Natural.
