
Annual Fundraising Dinner: NOVEMBER 21

Capacity Building Workshop: October 10

On October 10th, Prairie Rivers Network will hold a forum to further an on-going discussion about how we can build the technical capacity of people and groups working to protect Illinois' rivers and streams. All are welcome to attend.

The water pollution issues we face in Illinois are diverse and complex, requiring advocates to possess a broad range of knowledge and skills. Furthermore, technologies, regulations, and approaches are constantly evolving, making it difficult for even the most dedicated conservationists to keep up to speed and make sure their strategies are sound.

Supported by a grant from Illinois Environmental Protection Agency (IEPA), PRN is working with the IEPA, U.S. EPA, Hach Environmental, Illinois Lake Management Association, and Tetra Tech, Inc. to develop solutions to this "capacity" problem.

This summer, we developed and distributed a survey to assess the needs of individuals and groups working to protect Illinois waters. We hope to use the information gathered at our upcoming workshop and through the survey to help answer common questions watershed stake holders have, such as:

- How can we effectively share information?
- Who else in my area is trying to meet similar goals?
- What success stories are out there for the types of problems I am working on?
- What skills and tools does my group need to make progress?
- What resources are available to help us meet our goals?
- Who else should be involved in my effort?

It's our goal to work collaboratively to improve the ability of Illinois watershed stakeholders to successfully deal with water quality issues.

PRN Draws Attention to Pollution Risks of New "MEGADAIRY," Now Under Construction

In January 2008, when the snow was still falling on the rolling, scenic hills of the Apple River watershed east of Galena, Prairie Rivers Network received a call from Trout Unlimited. We were informed that the Illinois Department of Agriculture (IDOA) had received an application from a California dairyman to build what would be the largest dairy in Illinois. The application stated the dairy would



be located approximately 3 miles east of Apple River Canyon State Park, and would house over 10,000 cows on just a few hundred acres. The waste from these cows was predicted to approach 100 million gallons annually, and would require 70 acres of holding ponds. The manure ponds would be located next to a tributary of the Apple River, which means the river could be at risk of becoming significantly polluted in the event of a pond overflow, spill, or illegal discharge. In addition, the underlying aquifer would also probably become contaminated because all ponds leak to some extent.

A group of local citizens (H.O.M.E.S.) concerned about these environmental issues, as well as the likelihood of stench and lowered property values, had already formed to oppose the application. One of our first steps was to contact this group to find out more about the issue and to provide them with technical assistance. We then joined forces with H.O.M.E.S., Trout Unlimited, Environmental Law & Policy Center, and Illinois Environmental Council to strategize and work together.

From January through May, our coalition made repeated efforts to inform the public, IDOA, the Governor's office, and many other government bodies about the potential negative impacts of this "megadairy." We engaged and mobilized the public statewide by sending out action alerts and publishing Letters to the Editor. We also sent letters to

the Jo Daviess County Board and IDOA, questioning the wisdom of this particular location for this particular facility. H.O.M.E.S. was especially vocal and devoted many, many hours to meetings, phone calls, research, and updating their website. They brought particular attention to the determination by several licensed geologists that the area is underlain by karst topography containing vertical fractures that could contaminate the underlying aquifer if the manure ponds were to leak.

We were successful in that this issue caught the attention and scrutiny of the Lt. Governor's and Attorney General's offices, as well as the media. Because of this attention, IDOA was held more accountable for ensuring proper compliance with state regulations. Unlike most projects which are quietly approved by IDOA without much outside comment or public awareness, IDOA was suddenly under the microscope. But despite all this work and evidence that the dairy may cause significant environmental and economic problems, the building permit was granted and construction has already begun (see picture below).



Why did we not prevail? The Livestock Management Facilities Act is the state legislation governing the construction of dairies and other confined animal feeding operations (CAFOs). This Act contains weak, nebulous language that does little to protect our rivers and lakes from suddenly becoming neighbors to man-made animal sewage ponds. The existence of weak legislation and loopholes is further affirmation of the importance and necessity of our work to protect Illinois' waterways. Prairie Rivers Network will continue to provide assistance to residents living near existing and proposed CAFOs, and we will work to reform state law so that our waterways have clear protections.

PRN Garners Support from Citizens and Elected Officials to Restore DNR Funding

On July 11th, Governor Blagojevich cut \$14 million from the Illinois Department of Natural Resources (DNR) budget. Some of the impacts of this drastic reduction were initially obvious: the cuts eliminated all of the annual funding for the Wildlife Prairie Park in Champaign; they also eliminated all of the funding for the third and final year of a regional water supply planning program. Staffing cuts would be deep in some departments, such as the Office of Realty and Environmental Planning (40%) and the Office of Water Resources (19%).

Other impacts, such as the decision to close 24 state parks

and historic sites, although coming weeks later, have only underscored the original questions of how our state natural resources are to be adequately protected and managed, and why the public should have to suffer by being denied access to some of our state's most popular outdoor treasures.

In response to the governor's budget cuts, Prairie Rivers

Network partnered with the Illinois Environmental Council, Sierra Club, Openlands Project and other environmental groups to hold press conferences at state parks throughout Illinois on July 22nd. The purpose of the press conferences was to draw attention to what the DNR budget cuts mean for Illinois residents: the loss of access to what for many citizens are the only public natural areas in which they can enjoy outdoor activities ranging from hiking to paddling to fishing; the inability of DNR to ensure adequate protection and management of valuable natural resources; the elimination of staff who carry out needed water surveys of thousands of miles of state rivers and streams. At many of these press events, elected officials attended to offer their support for Illinois state parks and to voice their commitment to restoring DNR funding.

Included in the budget cuts was \$2.1 million allocated for the third and final year of two pilot programs for regional water supply planning. In 2006, Governor Blagojevich issued Executive Order 2006-1 authorizing DNR to oversee a three-year regional water supply planning process with the assistance of the Illinois State Water and Geological Surveys. In the Governor's own words, "It is critical for Illinois to get ahead of the curve when it comes to water supply planning."

The efforts of the Northeast and East Central regional water supply planning committees have been derailed by the complete loss of funding for the final year of the planning process. While each committee has received reports that

> forecast future demands and water withdrawals, the final year's funds were to pay for studies by the Water Survey on impacts of these withdrawals on surface and groundwater supplies. Without full funding for the Water Survey's research, information integral to an accurate and complete report, and planning necessary to meet the water supply needs of

people and wildlife will be missing from the planning process.

During a one-day session on September 10th, the House unanimously passed an amended version of Senate Bill 1103, which restores \$2.4 million dollars to the Historic Preservation Agency and \$2.1 million dollars to DNR for the purpose of funding personal services and preventing the layoff of "frontline staff" and closure of historic sites and state parks. No funds were restored to complete the remaining research needed for the regional water supply planning efforts. Unfortunately, the House vote on S.B. 1103 will be meaningless unless the Senate also votes to pass the bill.

PRN urges its members to pressure your senators to pass S.B. 1103 as a start towards restoring the funds needed for managing our state park and water resources.
