## Proposed mine draws pushback from area residents

Business News	Rushville, Ill. — As the application process moves forward for Grindstone Management, LLC's Littleton Mine, many area residents are calling on the Illinois Department of Natural Resources

Not Rest Until It Has Poisoned Every Man, Woman And Child (The Awl)	IDNR Supervisor Scott Fowler explained that his department's area of legal authority in permit issuance covered a relatively narrow range of issues, and that many of these concerns would have to be brought to different government bodies.

5	"We think (these things) are very important to the community, and to people who live near the coal (we have a) specific set of rules that we have to judge an application by," he said. "That's a very mining from an environmental and coal mining standpoint.

"It doesn't encompass everything about the coal mining industry. All it does is look at environmental impacts, and reclamation

of the coal mine at the end of its mining." Fowler responded to each question raised at the meeting and identified a handful of hypothetical issues over which the IDNR could take action, but no substantive legal claim was raised against the proposed mine's operations.

The IDNR will continue to accept comments on the pending application until Thursday, July 23. Within the subsequent 60 days, the department will determine whether to issue, deny, or require modifications to the application.
