# **IEPA Reissues Industry Mine Permit Despite Egregious Violations**

Agency refuses to exercise its powers to deny permit

Prairie Rivers Network and the Illinois Attorney General have sued Springfield Coal Company for hundreds of water pollution violations at the Industry Mine. Despite a ruling by the Illinois Pollution Control Board finding more than 600 violations since 2004, the Illinois EPA has issued yet another permit to Springfield Coal. While we work to make the company pay the full price of its violations and clean up the mine site, Prairie Rivers Network is also challenging the new permit.

Urbana Champaign Sanitary District Determined to Sell Water

That's the question we want the Urbana Champaign Sanitary District to consult with scientific experts on <u>before selling water to Cronus Chemical</u>. Although the District has promised us they'll leave enough water in the streams, we want experts to say how much is enough. We also want the public to have a <u>right to enforce</u> this promise by allowing a third party to enforce minimum stream discharge commitments.

If you care about the Saline and the Copper Slough, especially if you are a ratepayer, please help by contacting the UCSD Board of Trustees.

The Board of Trustees is likely to make its decision on Monday, June 17th. Please contact them to say you support expert consultation and third party enforcement.

## Large Factory Farm in Sensitive Karst Region Approved by IDOA

Prairie Rivers Network has been working with Adams County residents who oppose construction of a large 5,000 hog farm in a sensitive karst area. Groundwater and aquifers in karst regions are particularly prone to water pollution due to the porous nature of karst geology and soils. The Illinois Department of Agriculture recently approved the construction of this hog farm, so neighbors and Prairie Rivers Network are evaluating next steps and legal options, including reform of the Livestock Management Facilities Act.
