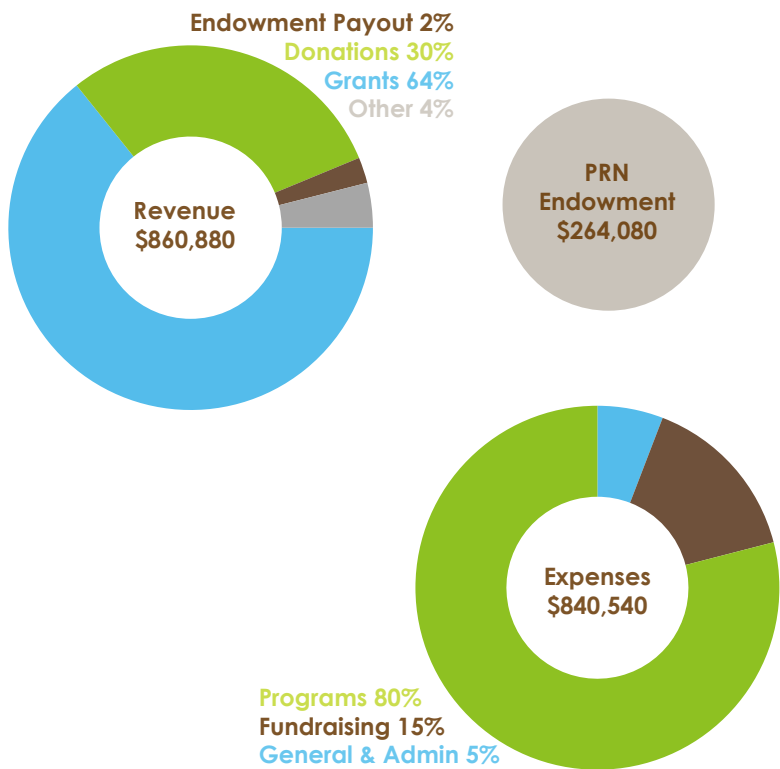


PRN 2017 ANNUAL REPORT

Thank you for protecting our water, rivers, and wildlife.

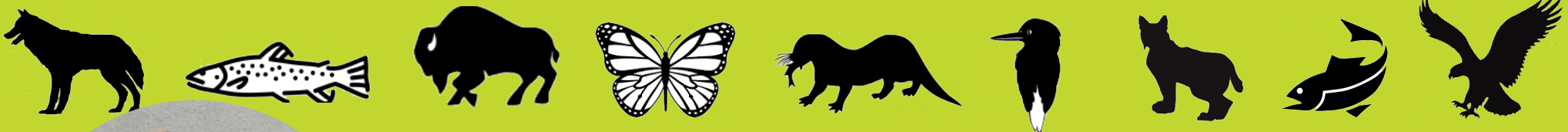

When you turn on the tap or drink out of a water fountain, you expect that water to be clean. Your membership donation helped get a law passed early last year that requires lead testing in schools and day cares. School can be hard enough on a kid; parents shouldn't have to worry if the water is safe to drink. Thank you for protecting our children.



YOUR SUPPORT ADVANCES RENEWABLE ENERGY

Climate change is real. Coal is a big contributor. Holding the coal industry accountable for their toxic waste and speaking up about the true cost of burning coal and coal mining on our communities helps advance the transition to renewable energy. When hikers along the Middle Fork River noticed an unknown white substance (likely coal ash from Dynegy's coal-fired power station), they called PRN, and we helped sound the alarm. Your continued support has made PRN the go-to organization to hold polluters accountable when situations like these arise and move us closer to a renewable energy economy.



YOUR VOICE SPEAKS UP FOR OUR RIVERS

Before people started interfering, rivers were free to meander. Their floodplains held water during storms and naturally filtered out pollution. You spoke up for letting rivers be rivers and saved 50,000 acres of wetlands along our iconic Mississippi River. The great blue heron, egrets, and all the other wildlife thank you.



YOUR GIFT HELPS FARMERS

Farmers have a tough job. They grow our food despite shrinking profits, a changing climate, and pesky weeds.
