

#### YOUR SUPPORT HEALS LAND

PRN has worked to heal land by promoting and protecting pollinators.

Last spring, we worked with farmers and landowners to install plantings of native flowering plants on farms. The seeds gathered from these plantings will be cleaned, dried, and distributed to other farms that want to protect and increase biodiversity. We would not be able to do this important work without your generous support!

#### YOUR MEMBERSHIP PROTECTS WATER

In 2019, we had major victories in our fight to protect water in Illinois. After years of work, advocacy, and grassroots organizing, the Coal Ash Pollution Prevention Act (Senate Bill 9) became law. The new law creates a regulatory framework to ensure polluters, not taxpayers, pay for their legacy of waste. Your membership made this and other victories possible. Thank you!

#### YOUR ACTIONS INSPIRE CHANGE

In May, PRN helped turn out more than 500 people to the Clean Energy Lobby Day in Springfield.
